## 20 YARD RENTAL AGREEMENT

### RENTAL PRICING

\_\_\_\_\_ \$385 (3 day) includes one dump with tonnage allowance of 2 tons.

\_\_\_\_\_ \$435 (7 day) includes one dump with tonnage allowance of 2 tons.

### ADDITIONAL SERVICES AND FEES

\_\_\_\_\_ \$25 per day rental extension with a max of 3 days. If the dumpster is still needed after the third extension day, a fee of \$50 per day will be charged.

\_\_\_\_\_ \$80 fee for every ton over included tonnage allowance (This rate will be prorated).

\_\_\_\_\_ \$50 fee if customer requests to move dumpster after initial placement.

\_\_\_\_\_ \$100 dry run fee if dumpster is blocked or inaccessible on scheduled pick-up day.

\_\_\_\_\_ \$200 fee for each additional dump and return requested by customer during rental period. Tonnage fee will be additional and based on actual scale ticket.

\_\_\_\_\_ \$50 fee per prohibited item found upon dumping (batteries, tires, etc.).

\*\*There are no refunds or discounts for unused rental days.

\*\*All rental period extensions depend on availability.

### IMPORTANT THINGS TO REMEMBER

Location for dumpster placement is sufficient to bear the weight and size of dumpster, prospective waste materials and any vehicle required to transport the dumpster.

Countryside Dumpster Service LLC shall not be responsible for any damage to pavement or any other road surface material, lawn, fences, shrubbery, septic system, private well or any other form of property damage. Precautionary measures will be taken to reduce risk of damage.

Do not attempt to move the dumpster once it has been placed to avoid possible damage or injury. Please call to schedule for it to be moved safely by us.

Do not fill dumpster past the **MAX FILL LINE**.

--The tarp must be able to roll completely over the top without obstruction.

- The end doors must be closed and secured before it can be removed.
- Overfilled or unprepared containers will be brought into compliance at customer's expense.

## PROHIBITED ITEMS

- Hazardous, radioactive, or toxic wastes
- Explosives
- Bulk liquids, hot tar, adhesives, wet paint
- Highly flammable or volatile substances
- Septic tank pumping
- Waste oil
- Lead-acid batteries
- Animal carcasses
- Tires
- Dirt, Concrete, Rocks

Customer is fully responsible for the entire contents of the container and is the rightful owner of the container's contents until the container is dumped and contents accepted by the prospective disposal facility. In the event unacceptable or hazardous materials are found, the customer will be responsible for any associated charges. Costs may include but not limited to cleanup, monitoring, legal fees, penalties, or any other charges associated with unauthorized or hazardous material disposal. Unauthorized materials may also be returned to the customer at the customer's expense.

Customer is responsible for obtaining any necessary permits, approvals or fees that may be incurred in conjunction therewith.
